Rules for Vendors:

1. NO WEAPONS OF ANY KIND to be sold. This includes all firearms (pistols and rifles) whether antique, firing replicas, or post 1898.
2. NO LIVE AMMUNITION to include black powder or substitutes may be sold.
3. NO EDGED WEAPONS OR KNIVES/BAYONETS of any kind may be sold.
4. NO AIRSOFT OR PAINTBALL RIFLES OR PISTOLS of any kind may be sold.
5. NO NIGHT STICKS, BILLY CLUBS, ETC. may be sold.
6. NO ALCOHOL OR DRUGS PERMITTED ON THE GROUNDS.
7. NO OBSCENE OR RACIST LANGUAGE OR MATERIALS OF ANY KIND.
8. NO SUBLETTING VENDOR SPACE OR SALES OUTSIDE YOUR ASSIGNED SPACE.
9. The management reserves the right to have any items it deems inappropriate removed from the show area.
10. ADHERENCE TO FEDERAL, STATE AND LOCAL LAWS regarding type of merchandise and the collection of taxes is your responsibility.
11. FULL DISCLOSURE. You are obligated to honestly and properly present your merchandise.
12. SAFETY. All vendor areas must be kept safe. Tent stakes and guy wires must be adequately and properly marked with warnings.
13. TRASH. You are responsible for the cleanliness and orderliness of your assigned area which must be spotless when you depart.

Conditions:

1. Each vendor stall is out-of-doors and is 15 feet wide by 20 feet deep. Vendors must provide their own tables and tents. Surface is LAWN.

2. Each vendor stall contracted entitles the vendor to two vendor admissions (if applicable) both of whom must be identified in advance. Vendor identification wristbands will be provided (if applicable). Additional people are charged the admissions fee if applicable.
3. Vendor stalls cost \$25.00 each. Vendor can contract for multiple stalls.
4. Stalls must be reserved in advance, and no later than 10 days prior to the event.
5. Payment is due at the time of application and is not refundable unless the show is canceled. Make checks payable to the **Orange County Farmers Museum**.
6. Applications will not be accepted unless signed below.
7. Public is admitted at 10 AM and departs at 4 PM. You must be setup prior to the arrival of the public and your vehicles parked in the designated parking area. Vendor vehicles are not permitted in show area unless the vehicle in question is an actual part of the stall.
8. Vendors must obey the Rules for Vendors noted below.
9. Event will not take place if raining.

What items do you generally sell?

The Orange County Farmers Museum and Orange County, its agents and employees shall not be liable for property damage, theft, or personal injury to Exhibitor, its agents, employees or guests which may occur on or about any part of the subject premises, regardless of how such injury or damage may have occurred. Exhibitor waives any claim against, and assumes all liability for loss or damage of Exhibitor property entrusted to the premises. Exhibitor shall hold the Orange County Farmers Museum and/or Orange County harmless and shall indemnify the Orange County Farmers Museum and Orange County against any liability or expenses arising out of any claim or injury or damage to any person or property, together with all costs in connection with the defense thereto, including attorney fees.
